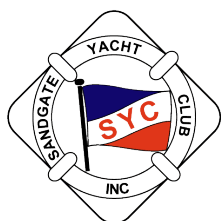

THE FROSTBITE REGATTA WILL BE CONDUCTED ON LESLIE DAM, WARWICK, QUEENSLAND ON THE 20th – 21st JULY, 2024. SANDGATE YACHT CLUB INC. IS THE EVENT HOST CLUB AND WILL ACT AS THE ORGANISING AUTHORITY.

NOTICE OF RACE

1. Invitation

Sandgate Yacht Club Inc (SYC), as Organising Authority, invite owners of suitably found dinghies, yachts and trailer sailers to enter in Frostbite Regatta, to be sailed on Lake Leslie in conjunction with Warwick Sailing Club (WSC) on the 20th and 21st July 2024

2. Rules

2.1 The races shall be governed by the rules as defined in the 2021 – 2024 Racing Rules of Sailing (RRS) of the International Sailing Federation (ISAF)

2.2 The YA Prescriptions and Special Regulations Part 1

2.3 The Class Rules of competing boats

3. Safety

3.1 The safety category for off the beach boats will be Off the Beach

3.2 The safety category for yachts will be Cat 6

4. Classes and Handicaps

4.1 Racing will be provided in the following Classes subject to at least three entries being made or accepted in that Class. Should there be insufficient entries to form a particular Class, yachts entered for that Class may be allocated to another Class at the discretion of the Race Committee or have her entry fee refunded. The Race Committee may alter, amalgamate or divide any class and may add classes as required.

4.2 CBH, Class. Additional handicaps may be available depending on fleet sizes.

5. Entry

5.1 Entry is open until 0800hrs 20th July 2024. Entry can be made via email to secretary@sync.org.au or in person at WSC on the day of racing.

6. Entry Fee

Race entry for the weekend is \$30 and is payable until 0800hrs 20th July 2024.

7. Schedule

7.1 The racing format shall be a series of round the buoys racing and a marathon race around the lake

7.2 The first race shall start no earlier than 1200hrs 20th July 2024

8. Handicaps

8.1 Handicaps shall be posted at WSC prior to racing.

8.2 The decisions taken by the Handicap Committee are final and there will not be cause for requests for redress from such decisions.

9. Sailing Instructions

The Sailing Instructions will available at WSC on race day

10. Scoring

All races shall be scored. No drops.

11. Insurance and Liability Risk

11.1 By lodging an entry, the owner/charterer agrees that:-

11.1.1 Entrants are reminded of the Fundamental Rule: Decision to Race which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

11.1.2 it is a fundamental condition of entry that he, she or it releases, holds harmless and Indemnifies the SYC and its associates, its office bearers, servants, volunteers, agents and members from all liability any of those persons has to the owner/charterer or any crew member on the owner/charterer's yacht, or to any person claiming through or under any such person arising from loss or damage how so ever caused, including negligent act or omission, arising out of or relating to: participation by the owner/charterer's yacht or any other yacht in a race; the conduct or course of the race in any respect including, without limitation, any act or omission (whether reasonably foreseeable or not) causing or relating to loss of or damage to any yacht or the death or injury of any person; or any of the matters referred to in the paragraphs above;

11.1.3 participation by the yacht and by the crew is agreed by SYC on the basis that participation is entirely at the risk of the owner/charterer and each member of the crew on the owner/charterer's yacht.

11.1.4 the owner/charterer shall provide each crew member or proposed crew member with a copy of these Conditions of Entry.

11.2 It is a condition of entry that competitors participate in this regatta entirely at their own risk (see RRS 4. Decision to Race), and that each yacht shall carry public liability insurance, with a sum insured of at least A\$10,000,000 or the foreign currency equivalent.

11.3 All those taking part in these races are reminded of their obligations as set out YA Special Regulations Clause 1.02 – "Owner's Responsibility".

12. Location, Camping and other information

Warwick Sailing Club is located on water's edge on Saddledam Road which is on north-eastern side of Lake Leslie (Leslie Dam). <https://goo.gl/maps/zYfMAUbPisSdKJYg6>

On site camping will be available from Friday 19th July to Monday 22nd July. Fees for non-members of Warwick Sailing Club will be \$15 per person per night, or \$25 per family per night.
